**Blind Mailing of Canvassing Materials
Election of Active Trustee For Term Beginning
December 1, 2010**

The Firemen's Annuity & Benefit Fund of Chicago will not distribute mailing labels containing the names and addresses of Fund participants eligible to vote in any Trustee election directly to any candidate in an election.

Candidates for the office of Trustee will be provided access to eligible voters through a "blind" mailing process established for purposes of the elections.
