AWARD OF DUTY DISABILITY BENEFITS PURSUANT TO ORDER OF THE CIRCUIT COURT:

16353 MAUREEN MILOTA, payment of Duty Disability benefits beginning November 23, 2004, plus attorney's fees pursuant to order of the Circuit Court, Judgment entered September 22, 2006. Monthly benefits beginning November 23, 2004 of \$3,328.00 per month increased to \$3,426.75 effective June 1, 2006 pursuant to new contract salaries.
